ORDER:

In the letter first read above, the Director, M.N.J. Institute of Oncology Regional Cancer Centre, Hyderabad has submitted proposals to Government for establishment of certain Departments in M.N.J. Institute of Oncology and sanction of staff. He has stated that the MNJIO & RCC, Hyderabad is a 250 bedded tertiary care referral cancer center with occupancy of more than 350 patients. It is the only cancer center in the State to provide surgery, radiotherapy and chemotherapy free of cost to patients below the Recently, a Pediatric Medical Oncology ward was started for poverty line. childhood cancer patients, were mainly leukemia cases are being treated. The adult Medical Oncology patient with Leukemia's and Lymphomas are being admitted in other wards. Further, the Department of Pain & Palliative care was started in the Institution on 1st July 2006, which had been functioning with funding support of various international organizations. One consultant from the International Network for Cancer Treatment and Research (INCTR) was posted for two years support for the whole programme.

- 2. The Director, MNJIO & RCC Hospital has stated that the Department of Pain and Palliative Care is functioning with the help of the doctors from Radiotherapy Department, Nurses, Volunteers and workers. However, there is no full-fledged staff for this Department. Keeping in view the importance for establishing three full-fledged Departments of Medical Oncology, Pain and Palliative Care in the institution, he has requested for creation of certain posts in the said Departments and requested the Government to accord administrative sanction for creation of the posts in various categories by providing additional budget for smooth functioning of the above two (2) Departments.
- 3. The Health Medical & Family Welfare Department vide their U.O. second read above proposed for creation of thirty posts in MNJIO & RCC Hospital, Hyderabad.
