The H.M. & F.W. Department has stated that the Director, Mehedi Nawaz Jung Institute of Oncology & Regional Cancer Centre, Hyderabad in the references 1st & 2nd read above has stated that the institution was established in 1955. Efforts are being made to strengthen the laboratory services by procuring additional equipment and to start Molecular Oncology Department, which is an emerging new specialty in cancer diagnosis and management. The main objectives to start this department is to provide-

1. An epidemiological survey of cancer patients and animal model studies for the causative agents (HP Viruses, diets etc) at molecular level.
2. Risk assessment of genetically related cancers.
3. Karyotype analysis and evaluation of cytogenesis damage in cancer patients.
4. Identifications of specific mutation sites at Molecular level of function and D.N.A. expression profiles, proteomics.
5. Clinical research (tolerance (drug) targeted treatments etc.)
